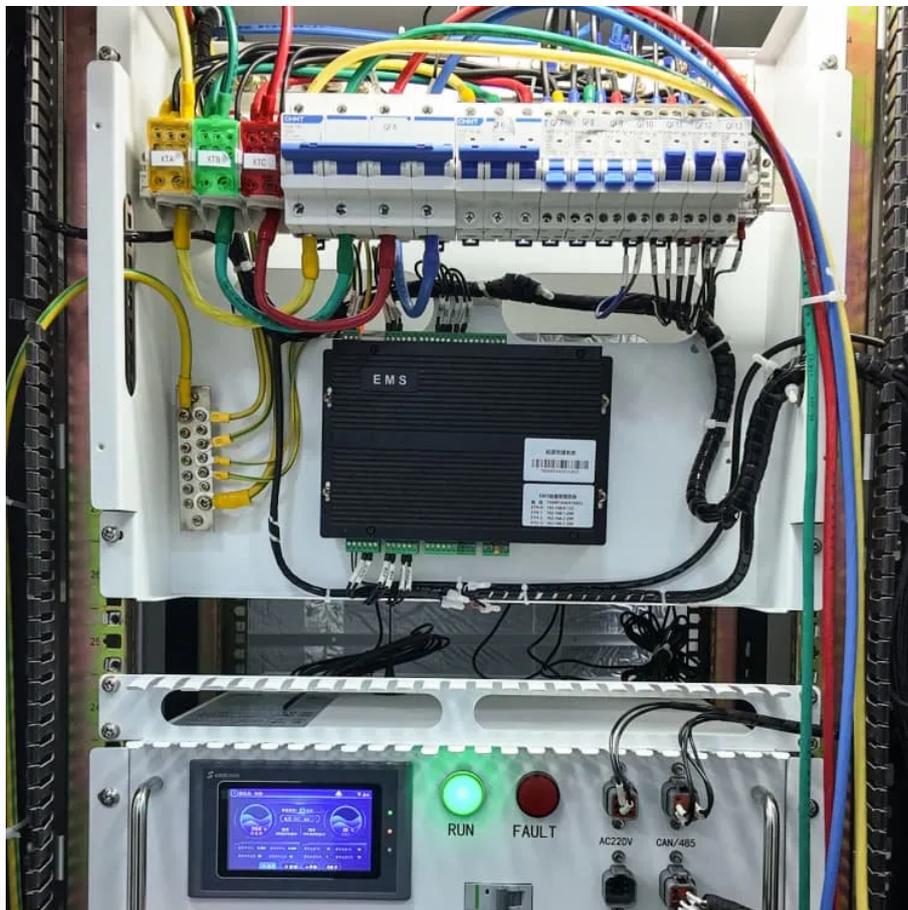

The loan can be paid at commercial operation or even later. The loan has capitalized interest that accumulates until the loan is paid.

How is construction financed?

Construction is funded by sponsor equity and a construction loan. Once constructed, the sponsor sells the project to the investors that have formed a trust and immediately leases it back. The developer repays the construction loan from the sale proceeds. The trust is financed with cash equity and a non-recourse term debt.

How does a project get funded?

Most of the funding comes from loans, which are repaid mainly from the cashflows the project generates. This method is often used for large projects that need a lot of money upfront. The project's risks are shared among the stakeholders, usually through a special purpose vehicle (SPV), a separate company created just for this project.
