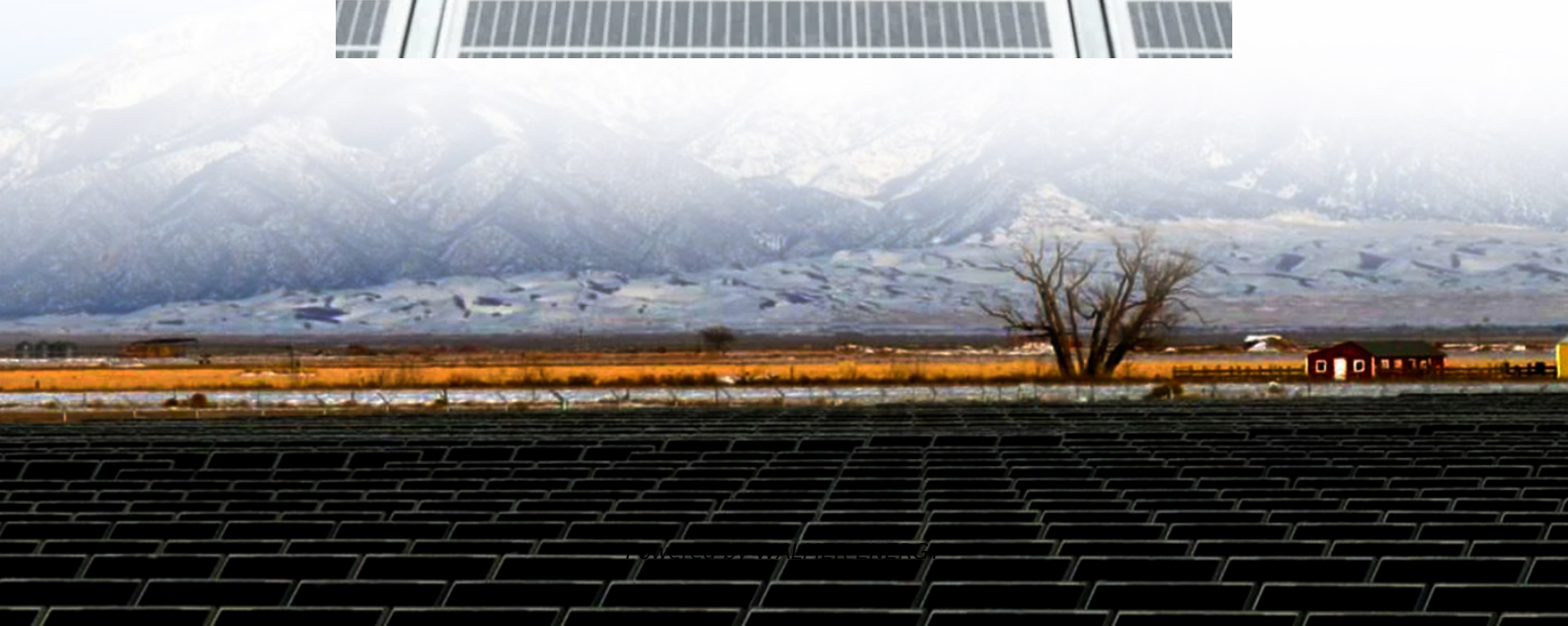


Solar and energy storage warranty period

How long does a solar panel warranty last?

The length of a product warranty varies based on the manufacturer and model. Traditionally, these warranties typically last 10-15 years, although it is becoming more common for premium panels to have 20 and 25 year product warranties. If a panel fails within the warranty period, the manufacturer will typically replace or refund the panel.

Do solar panels have a performance warranty?

Performance warranties are important for sizing solar systems to maintain 100% offset for 25 years. It's important to note that the performance warranty guarantees the panel's ability to produce a certain amount of electricity - not that the panel will produce that amount.

What is a battery energy storage system (BESS) warranty?

As challenging as warranties are for battery energy storage system (BESS) owners and operators, it is possible for there to be more clarity. Look no further than how the automotive industry handles electric vehicle warranties. They are simple and flexible, typically covering time (usually eight years) and mileage (usually 100,000 miles).
