Overview

What are the new energy conservation standards for external power supplies?

The U.S. Department of Energy (DOE) has recently proposed new energy conservation standards for External Power Supplies (EPSs). These proposed standards, known as Trial Standard Level 4 (TSL4), aim to tighten energy efficiency requirements across all types of EPSs. TSLs are a tool used by the DOE to set energy conservation benchmarks.

What is the external power supply conservation standard rulemaking docket eere-2008-bt-std-0005?

The external power supply conservation standard rulemaking docket EERE-2008-BT-STD-0005 contains all notices, public comments, public meeting transcripts, and supporting documents pertaining to this rulemaking. There is no public meeting scheduled at this time. The comment period is closed.

Do manufacturers have to comply with energy conservation standards?

Manufacturers have been required to comply with the U.S. Department of Energy (DOE) energy conservation standards for external power supplies since 2007.

What is an external power supply?
